Dear STREAM TEAM and Volunteer Water Quality Monitors:

Enclosed is the 2010 Level 2 Volunteer Water Quality Monitoring Workshop Summer Schedule. In order to be eligible to attend you must have completed an Introductory and Level 1 workshop, submitted stream discharge data where possible, water chemistry and invertebrate data. The focus of these workshops will be Quality Assurance/Quality Control (QA/QC) procedures to improve the quality of volunteer data.

The entire workshop will be held indoors. The morning will be spent analyzing water samples using the chemical equipment you were issued after your Level 1 class, **SO BE SURE TO BRING ALL YOUR CHEMICAL EQUIPMENT** (and ensure your pH meter is properly hydrated just before you attend). The afternoon will be spent improving your aquatic invertebrate identification skills. A short evaluation will follow to help establish baseline information on the accuracy of volunteer biological data.

Attention to all VWQM that are collecting Ammonia data (NH₃):

Ammonia Kit Recall! If you are using the Hach-Model NI-8 test kit or any other ammonia kit that requires Nessler's reagent please let us know. Why the recall? Nessler's reagent contains mercury. Minimizing mercury releases from all sources is important. Methyl mercury contaminates the food chain and builds up in the tissue of fish and wildlife and humans that eat contaminated fish. Replacement kits are ready to be mailed to volunteers as we receive the recalled kits. To make arrangements to receive a new kit and send in your old kit, contact Priscilla Stotts.
